GENERAL TERMS & CONDITIONS

Request for Tender

The Mauritius Society of Author (MASA) is inviting competitive bids from potential buyers for the Executive: **Honda Accord Saloon, Color: Blue - Year: 2003, Rating: 1998 cc - Petrol** and on an **'As is and Where is'** basis.

Validity Period

Bids shall be valid for a period of 90 days after the closing date of the bids. MASA reserves the right to request for extension of the validity period prior to the expiry date.

Site visit

The purpose of the site visit is to take cognizance of the vehicle on sale prior to submission of bids.

All expenses incurred by potential bidders to attend the site visit shall be borne by the bidders.

Basis of Pricing Sought

Bidders shall quote in Mauritian Rupees only and inclusive of VAT. The price quoted including VAT shall be firm and fix during the validity period. No claim on behalf of the buyer shall be entertained by MASA for any reason which may become apparent during the handing over/delivery process.

Bid Security

Bidders shall have to submit a Bid Security in the form of an Office/Bank Cheque issued in favour of MASA, amounting 2% of their bid price together with their bid. Non-submission of Bid Security shall entail to rejection of bids.

The Bid Security shall be forfeited in case their bid is accepted and the bidder refuses to proceed with the execution of the contract award.

Bid security of all unsuccessful bidders shall be returned after the award of contra

Evaluation of bids

Bids received shall be evaluated on the basis of price quoted. Bidder offering the highest price shall be awarded the contract, subject to the compliance with this bidding document and the General Terms & Conditions.

Payment

Successful bidder shall have to call in person at the Procurement Department – MASA House, Avenue des Artistes, Beau Bassin for the sale formalities. Payment should be made for the full amount due in respect of the allocation within TEN (10) days after issue of Letter of Acceptance.

MASA shall accept payment by Office/Bank cheque (ONLY), Cash payment, part payment and personal cheque shall not be accepted. Invoice and all other documents related to this sale shall be issued in favour of the successful bidder also called the Purchaser.

Delivery

The vehicle has been parked at the Mauritius Society of Authors (MASA) – Avenue des Artistes, Beau Bassin and same shall be delivered during office hours, as from 9.00 hrs up to 15.00 hrs.
